Indeed, many of you expressed concerns that their investment in an expensive booth didn't yield the results they hoped for in terms of interaction with surgeons.





All cancellations must be made in writing. The cancellation penaltics are as follows: 50% of the total sponsorship fee if booking cancelled before 15th October 2020. After that date, 100% of the total sponsorship fee will be retained.
